



Mardel HKC Vendor – Sample Shipping Instructions

Overview

These sample shipping instructions include procedures for Mardel HKC Vendors. Unsolicited shipment of samples will not be accepted; therefore, samples need to be requested by a Mardel Buyer or HKC Merchandiser in order to be shipped.

Any penalties Mardel incurs from Customs Border Protection due to vendor's failure to comply, Mardel will chargeback to the vendor; this includes any cost(s) associated with the penalties.

Hobby Lobby's International Department audits a random sampling of shipments each quarter. Failure to comply could result in penalties or fines.

HKC Vendor Instructions

These instructions are organized by sample type. Click on the sample type below to be directed to the appropriate procedures.

<u>New & Pre-production Samples</u>
Commercial Sample Program: Duty free entry – 9811.00.60 Unsuitable for sale or for use other than as a sample
Samples DO NOT have an existing PO and CAN BE DEFACED.

<u>Production Samples</u>
Mardel Email Program: Regular Entry Suitable for intended use or sale
Samples HAVE an existing PO and CANNOT BE DEFACED.

New & Pre-production Samples: Commercial Sample Program

This section contains procedures for new and pre-production samples using the **Commercial Sample Program** under the provisions of U.S. Harmonized Tariff Code (HTS) 9811.00.60.

HTS 9811.00.60 Exceptions

Any new and pre-production samples that are dried flowers, foliage, and/or feathers not incorporated into a finished article or contains lithium batteries are considered exceptions and are NOT ALLOWED to be shipped under the HTS 9811.00.60.

 - Attach the *Mardel Email Program – Sample Submission CIPL* located at the end of these instructions.

HTS 98.11.00.60 Allowances

New and pre-production samples that do not have exceptions as listed above can be shipped commercially with HTS 9811.00.60 under one of the two following duty-free provisions:

1. **DO NOT DEFACE**: Samples that have a quoted First Cost value equal to or less than \$1.00 (USD).
OR
2. **DEFACE**: Samples that have a quoted First Cost value greater than \$1.00 (USD) need to be defaced in one of the following ways rendering the samples unsuitable for sale or for use other than as a sample:
 - a. **Mark** the sample permanently by indelible embossment, ink, paint, laser, etc. with the words “SAMPLE – NOT FOR RESALE” being 2 inches in length and 0.50 inches in height (minimum) located in a prominent, visible, main body portion of the sample itself, not the packaging.
OR
 - b. **Damage** the sample by tearing, perforating, or punching a hole making the sample unsuitable for sale or for use other than as a sample if the sample cannot be marked due to size or nature.

Production Samples: Mardel Email Program

This section contains procedures for production samples using the *Mardel Email Program*. HKC Vendors will work with the HKC Merchandising and Verification Teams on requirements.

1. When completing the [Mardel Email Program – Sample Submission CIPL document](#), email efiling@hobbylobby.com for assistance in completing “VERSION ID” or “DISCLAIM”.
2. Email hk-vtclass@hkconnections.com.hk and Cc the HKC Merchandiser with the following information per sample:
 - a. **Subject Line:** “Mardel Email Program Sample Submission CIPL – Vendor Name”
 - b. **Attachment:** Completed *Mardel Email Program - Sample Submission CIPL* document.
3. HKC Merchandising and Verification team members will communicate sample status via email and provide guidance for shipping the samples to HKC with the goal of maintaining sample integrity and safe delivery to the Mardel corporate offices.

IMPORTANT NOTE: Refer to the Purchase Order (PO) associated with the sample for testing information; if the PO states testing is required, HKC will not ship the sample to the US until they receive a passing test result.

Shipping & Handling

This section contains procedures for shipping samples to HKC. Do not ship until samples have been successfully prepared and approved as guided by HKC team members. Follow the shipping and handling steps below when preparing shipment to HKC:

1. **Sample Tag** – ensure each sample in the shipment has an attached Mardel Sample tag. The sample tag template for all Mardel sample types is located on the [Vendor Documents page](#).
2. **Required Import Documents for China, Vietnam, or Hong Kong** – if importing into China, Vietnam, or Hong Kong, include two copies of the invoice and packing list, and include one copy of the courier air waybill. If shipping within the respective country, there are no required documents. The HKC Merchandising Team will guide vendors as needed.
3. **Ship** – HKC Vendors are to ship samples to the Hong Kong Connections office in either Shenzhen, Vietnam, or Hong Kong as guided by the HKC Merchandising Team:
